TERM DATES:

PAYMENT OF FEES

Little Hands preferred payment methods are direct bank payments or Childcare vouchers. Payments should be made within 2 weeks of the invoice date or a late pay fee of £20 will be added. Alternative payment arrangements (cheque or cash) or timings may be possible please speak to the nursery manager in advance

Direct Bank Payments

Fees can be paid directly into the nursery bank account either at a bank/post office or via Internet banking. The nursery bank details are:

If email is not an option the written notification can be given as a note/letter to the nursery manager.

Childcare Vouchers

Working parents can choose to pay using Childcare Vouchers if their employer is part of a voucher scheme. Voucher payments are popular as they are exempt of tax & national insurance deductions. The voucher company should be instructed to notify the nursery by e-mail when the payment is due so that individual payments can be correctly tracked.

Cheque payments

Cheques should be made payable to Little Hands Nursery.

Cheques are banked in the week following the payment period (two weeks after the invoice date.) Please note that cheque payments made outside the payment period may be not be banked until the following half term. Nursery will pass all bank charges incurred from un-cleared cheques to the parents.

Website

Entrance Hall

Please remember that the entrance hall is a common area which is used by other users of the hall. Children should be supervised at all times and must not be allowed into the adjacent corridor, or to play on the glass door into the hall. Noise level should be kept to a minimum and other people need to be able to pass safely through at all times.

Bad Weather

Please remember that we like to go outside to play each day so please ensure that your child has suitable named clothing and footwear every day. Please bring a change of clothes for your child in case of accidents or if your child gets wet or dirty clothes during an activity. These can be left in a bag on their peg.

If you have any of our nursery clothes at home please return them to us as soon as possible as our supplies are running low!

Snow

There are circumstances which occur rarely, such as severe weather conditions, which may require the nursery day to be reconsidered or cancelled. It is possible that we cannot predict when these circumstances may occur. In cases of severe weather conditions it may not be possible for the staff to travel safely to the nursery. It may be advisable to ring the nursery to check that we are open before setting off from your homes. "Little Hands" will endeavour to provide an uninterrupted service to families whenever possible.

All About Me Folders

We will be making some small changes to the children's All About Me folders this term. The new summative records will be used for 50% of our existing children and all new children from the Spring term. We will be evaluating the new system to ensure that it is working ok during the next two terms. Please do not hesitate to speak to me if you have any concerns.

Communication Books

Communication books will be gradually phased out for our existing parents and not given to new parents unless they are requested. We will replace them with loose leaf sheets of paper for parents to send any information about their child into nursery. The completed sheets will be placed in the child's records under the relevant section and if appropriate used for their next steps.

Thoughts and Reflections Box

Just to remind you of our thoughts and reflections box that is in the entrance hall. It is there for you to put in any concerns, thoughts or wishes you may have for the nursery and do not wish to discuss with the staff.

We would like to invite any parent, carer or relative to join us at nursery to share any particular skill you may have with the children. In the past we have had a mother who talked to the children about her new baby, a father who is a keen cyclist, a mother who was a fitness instructor, a mother who sang Spanish nursery rhymes and a father who is a dentist. They came in and talked to the children for a few minutes which all the children thoroughly enjoyed. Parents have also come in to share festivals and celebrations that their families participate in. What does your child learn at nursery...?

Our nursery day is carefully planned using guidelines from the Early Years Foundation Stage (EYFS) curriculum and methods that have been highlighted as beneficial to children's learning and development through research in early years education. Our planning is based on the individual child, using our knowledge of the children, together with your knowledge of your children, as we feel you are the ones who know them best. The children here at Little Hands learn through play, and play has been recognised as the most effective learning tool by many early years theorists over the years. These early years are seen as the most important where children develop their likes, interests and learn new skills. Our job is to use these likes, interests and skills to help children to grow and develop in independence and confidence, and this in turn will boost their self-esteem, opening up their curiosity and desire for learning so that this can be carried on throughout their whole lives.

The first part of our session is 'free play;' this is a carefully planned and supervised time where the learning is child led. Our role as practitioners is to observe and extend the children's learning using these observations to determine the children's individual needs. Observations are also used by the children's key workers to plan 'next steps' in individual children's learning. During free play the practitioners use their skills and knowledge to gently enhance children's self-chosen activities, this is done without interfering or changing them too much, and the purpose of this is to extend the children's current knowledge or skills offering new opportunities and experiences that they may not necessarily be able to access for themselves. This method of teaching is known as 'scaffolding;' it involves an adult or older child demonstrating skills to a child who will then repeat it by themselves. We see this happening quite often at Little Hands. This is largely due to our high staff to child ratio which means children can be given the freedom to explore in a safe environment. It is also due to our mixed ages of children during 'free play'. Here the older children can show off their skills and knowledge which develops their self-esteem and the younger children learn from the older children who they enjoy playing with.

The next part of the session is adult initiated; during this time the children participate in 'focus play' where the activities are more structured to develop their knowledge and skills. The children are grouped according to their age and abilities and all activities are planned with the children's abilities, likes and interests in mind. This means that the activities they access are age appropriate; for example the preschool children may participate in activities that involve sitting and being engaged in a task for a length of time that would not be suitable for a two year old.

There is much research and evidence on the value of balancing child led and adult initiated activities in this way, and this is recommended by early years experts and the EYFS. The value of free play is supported by evidence from research in brain maturation and psychology which found that even the youngest of children show curiosity, make choices and persist at tasks to reach a goal. Free play encourages children to take ownership of their learning and learn valuable skills in areas such as negotiation, problem solving, creativity and imagination, developing their independence and confidence and providing them with a positive approach to learning. Structured activities on the other hand can help children develop their concentration, and introduces them to new experiences that they may not normally choose to access.

At Little Hands the children are enjoying their learning through play while the practitioners are using their skills and experience to ensure that each child is accessing the opportunities available to them, opening up possibilities for new experiences and opportunities for learning and monitoring children's progress along the way. The methods we use for assessment and monitoring progress are linked to the EYFS, which is a legal document for all early years settings in the UK, which requires that children access and achieve in seven areas of learning to reach the Early Learning Goals of each area using the individual child's characteristics of learning.

Little Hands has also put together a leaflet which explains the welfare and educational requirements of the EYFS, detailing the seven areas of learning and the various progress checks that are made throughout your child's time in the Foundation Stage, which begins at birth and ends at the end of the reception year. We send this leaflet out with a "review" meeting letter when your child has been at nursery for a few weeks. If you have any questions or would like some more information, we would be more than happy to help so please speak to us. To put this together, we have used information from the Department for Education document on the revised Early Years Foundation Stage (2012) and also Nancy Stewart's book, How Children Learn: The Characteristics of Effective Early Learning (2011).

Children's early experiences can either enhance or spoil their future possibilities, so it is vitally important that we get it right. Allowing children the opportunity to become self-regulated learners can open up their disposition to learning. Too much structure can result in quashing children's imagination, possibly damaging their approach to future learning, making children passive learners who depend on rote learning and specific instruction, while too much freedom may limit learning as it may not provide children with opportunities to teach all things to themselves; some experiences and skills need to be learned from adults. European countries such as Sweden and Norway employ a more play based approach in their early years education, and their children start school later than in the UK, but comparisons show that these children later exceed the achievements of learners from a more rigid and structured style of teaching.
